MOTION

STATE CUP REPORT

Chris Jamrozy presented the State Cup Report. This year he held online webinars for coaches and team managers that were well received. IYSA has 5 teams that have earned spots to the USYSA Nationals in Dallas through the National League: Raiders FC 16U Boys, Raiders FC 17U Boys, CFJ South 19/20U Boys, FC United 19/20U Boys, and Team Chicago 19/20U Girls.
